Anti-Money Laundering and Counter-Terrorism Financing Regulation (Amendment) Order No. 2 of 2015

In exercise of the powers conferred on me by section 53of the Anti-Money Laundering and Counter-Terrorism Financing Act No. 13 of 2014, I, the Honourable JOE NATUMAN, Prime Minister, make the following Order.

1 Amendments

The Anti-Money Laundering and Counter-Terrorism Financing Regulation Order No. 122 of 2014 is amended as set out in the Schedule

2 Commencement

This Order commences on the day on which it is made.
